## COLLEGE FOOTBALL PLAYOFF GAME BALL SWEEPSTAKES OFFICIAL RULES

## NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

**ELIGIBILITY:** College Football Playoff Game Ball Sweepstakes ("Sweepstakes") is open to legal residents who live within a seventy-five (75) mile radius from Houston, Texas (the "Territory") who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry.
